7. New conclusions:

Firstly, the thesis presents the central concept of the topic: *The work of developing party organizations in non-state enterprises in the Southeast provinces is the activity of the provincial Party Committee, Provincial People's Committee Party Committee; the Party Committees of communes and wards; the Party Committees and Party organizations in non-state enterprises with the participation of socio-political organizations, workers, employees of enterprises and organizations of the local political system in building, promulgating and implementing policies, resolutions, decisions and conclusions of the Party Committees on improving the quality of existing Party organizations in enterprises and establishing Party organizations in enterprises without Party organizations, creating favorable conditions for Party organizations to operate effectively.*

Secondly, the thesis builds the theoretical framework of the topic, clearly defining 05 contents of the work of developing party organizations in non-state enterprises in the Southeast provinces: 1) The Provincial Party Committee leads and directs the development and issuance of resolutions, directives, and conclusions regarding the development of party organizations in enterprises outside the state sector; 2) The Provincial Party Committee leads and directs the Provincial People's Committee Party Committee, the Party Committees of industrial parks and export processing zones, the Party Committees of communes and wards to implement the programs and plans for developing party organizations in non-state enterprises that have been concretized; 3) The Party Committee of the Provincial People's Committee, the Party Committee of industrial parks, export processing zones, the Party Committee of communes and wards lead and direct the coordination of activities of socio-political organizations, workers and laborers in enterprises, local socio-political organizations, and mobilize business owners to participate in developing party organizations in enterprises; 4) Build an organizational apparatus and cadres to do the work of developing party organizations in non-state enterprises with sufficient qualities, capacity and prestige to meet the requirements of developing party organizations in non-state enterprises in the locality; 5) Party committees conduct inspections and supervision of the work of developing party organizations in non-state enterprises; 6) Maintain the routine of periodically reviewing, summarizing and drawing experiences on the work of developing party organizations in non-state enterprises.

Thirdly, the thesis proposes two new breakthrough solutions: 1) Improve the quality of existing party organizations in non-state enterprises, focusing on improving the quality of Party committees; Party members and innovating the content and methods of Party organization operations; 2) Promote the establishment of Party organizations in non-state enterprises that do not have Party organizations and create favorable conditions for Party organizations to operate effectively.
