7. New Contributions of the Dissertation:

Firstly, the dissertation provides a rich and updated body of documentation on the leadership of the Binh Dinh Provincial Party Committee in implementing social welfare policies from 2010 to 2020. During this period, the Committee issued numerous resolutions and directives to concretize the Central Government's social welfare guidelines. The materials include a chronology of events, thematic reports, and statistical data from the provincial Social Insurance agency. The health insurance coverage rate increased significantly, and citizen support policies were effectively implemented. The living standards of the population improved markedly thanks to the integration of economic development and social welfare efforts. These sources serve as an important foundation for further research and practical review.

Secondly, the dissertation contributes to reconstructing the process by which the Binh Dinh Provincial Party Committee led the implementation of social welfare from 2010 to 2020, across five key areas: Social preferential policies: The province prioritized care for people with meritorious service, providing housing, healthcare, and education support to policy beneficiaries; Employment and poverty reduction: Vocational training programs, preferential loan schemes, and the new rural development initiative significantly reduced poverty rates; Social insurance and unemployment insurance: Coverage was expanded through various measures to promote voluntary social insurance and support workers affected by job loss; Social assistance: Regularly implemented through emergency and long-term support policies for vulnerable groups; Minimum standards for basic social services: Ensuring access to healthcare, education, and clean water helped improve the overall quality of life for the population.

Thirdly, based on a thorough examination of documentary sources and practical review, the dissertation offers an objective, comprehensive, and scientific assessment of the Binh Dinh Provincial Party Committee's leadership in implementing social welfare policies during the 2010–2020 period. By analyzing both strengths and limitations, and identifying underlying subjective and objective causes, the dissertation highlights distinctive features in the Committee's leadership approach. From this, it synthesizes valuable theoretical and practical experiences, shedding light on the role of Party organizations in the field of social welfare. The research findings not only serve the purpose of practical review at the local level but can also be appropriately applied to leadership and governance efforts in other provinces and cities nationwide. Furthermore, the dissertation provides a scientific foundation for formulating social welfare policies in the new context, meeting the demands of sustainable development while ensuring social progress and equity.
